

iSEE Store Innovations LLC Limited Warranty

This warranty is made to the original purchaser and is not transferable.

iSEE Store Innovation (iSEE) products are warranted to be free from defect in material and workmanship under normal use and service for a period of one (1) year from the date of verifiable purchase by the end-user from iSee or from an iSee authorized distributor. In the event that verifiable sales information is unavailable, iSee may choose, at its sole discretion, to honor the warranty, provided that it has not exceeded eighteen (18) months from the date of manufacture. ISEE's obligation under this warranty shall be limited to repairing or exchanging any product or any part of its products, without charge from the F.O.B. distribution center or nearest authorized parts depot within said period and which is proven to the satisfaction of the iSee's warranty group to be thus defective.

ISEE covers the entire product and all its components (except fuses, and other wear type replacement parts) for the one (1) year warranty period.

Compressors are warranted for a period of five (years), and after the first year cover the cost of the compressor only, not its installation, freight costs, labor, or other incidental costs.

Additionally, ISEE warrants for a total period of three (3) years all sealed, multi-glass windows or doors. If within three (3) years from the date of purchase, it shall be proven to the satisfaction of the iSEE warranty group that there is impaired visibility through the multi-glass assemblies thereof caused by moisture between the glasses, the multi-glass assembly or the entire product (at iSEE's sole discretion) will be replaced free of charge, F.O.B. factory.

This warranty excludes accident, misuse, or glass breakage.

THE WARRANTIES TO REPAIR OR REPLACE ABOVE RECITED ARE THE ONLY WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, MADE BY ISEE WITH RESPECT TO THE ABOVE MENTIONED EQUIPMENT, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS, AND ISEE NEITHER ASSUMES NOR AUTHORIZES ANY PERSON TO ASSUME FOR IT, ANY OTHER OBLIGATION OR LIABILITY IN CONNECTION WITH THE SALE OF SAID EQUIPMENT OR ANY PART THEREOF.

THIS WARRANTY SHALL NOT APPLY TO LOSS OF FOOD OR CONTENTS OF THE EQUIPMENT DUE TO FAILURE FOR ANY REASON. ISEE SHALL NOT BE LIABLE:

- For any repair or replacements made without the written consent of ISEE;
- When the equipment is installed or operated in a manner contrary to the printed instructions covering installation and service which accompanied such equipment;
- For any product that has been used contrary to its normal intended purposes;
- For any damages, delays, or losses, direct or consequential which may arise in connection with such equipment or part thereof;
- For damages caused by fire, flood, strikes, acts of God or circumstances beyond its control;
- When the equipment is subject to negligence, abuse, misuse or when the serial number of the equipment has been removed, defaced, or altered;
- When the equipment is operated on low or improper voltages;
- When the equipment is put to a use other than normally recommended;
- When operation of this equipment is impaired due to improper drain installation, when necessary;
- For payment of product loss for any reason;
- For any costs related to shipping or handling of replacement parts.
